Goal:

This internship provides an opportunity for an Australian or Malaysian tertiary student to undertake an internship in a Malaysian business context.

The offer is the prize for an Australian or Malaysian student from an Australian University or VET institution who submits the most convincing and engaging submission outlining the benefits of such an experience. The prize also includes a return flight from Australia to Malaysia, sponsored by Malaysia Airlines.

GUIDELINES FOR APPLICATION

Applicants are required to write an essay not exceeding 2,000 words (excluding footnotes) or create a multi-media or time based work between 3-5 mins. (All appropriated images and sound should be acknowledged in the credits or as a written addendum to the work. All submitted works must be able to be played on standard consumer hardware.)

- Submissions must be typed, double spaced on one side A4 size paper and appropriately referenced.
- A cover letter should be submitted for each submission to include:
 - Title
 - Student's family name (underlined) & other names,
 - Postal address
 - Contact telephone number
 - o Email address
 - Enrolment details with relevant university
 - Details of internship preferred

"Students without Borders- Studying in Australia, Interning in Malaysia"

ELIGIBILITY

- 1. Open to both Australian and Malaysian students enrolled at an Australian tertiary institution.
- 2. Students will be required to be in Malaysia for an internship with an assigned member company of MABC during the summer break in January 2011.
- 3. The duration and allowance for this internship will be at the discretion and advice of the participating company.
- 4. The winner will be responsible to organise their own accommodation and related costs during their internship in Malaysia.
- 5. The winner will be required to submit a written report or presentation to MABC on their experience as an intern upon the completion of their internship in Malaysia.
- 6. The winner may be required to attend an MABC function to make a short presentation on their internship experience.

SELECTION CRITERIA

- All entries will be considered by the MABC Education and Training Sub-committee. A short list will be created, by at least 3 members, for the full committee's final judgement. Judges' decisions are final and no correspondence shall be entertained.
- Submissions will be judged based on content and relevance, clarity and quality of communication, vocabulary, grammar and originality of ideas.
- MABC and AEI Malaysia reserve the right to publish the winning submission in an appropriate and reputable way.
- The panel of judges reserves the right not to make an award if it deems that no submission is of sufficiently high standard.
- The return flight is not transferable and may not be exchanged for cash.
- The competition is subject to MABC's terms and conditions and MABC reserves the absolute rights at any time to withdraw from and/or add to, modify, delete, waive or otherwise change or alter any of the terms, rules, conditions, benefits, prizes pertaining to the contest in part or total at its sole discretion, with or without notice to the contestant, at any time it deems appropriate.
